HWB Support for Right Care, Right Here and Midland Metropolitan Hospital

I am writing to set out my support with the Right Care, Right Here programme it is key to the future of health and social care in our local population. The governance of that work brings together statutory and third sector representatives across primary, secondary and tertiary provision, for both physical and mental wellbeing. In 2013 we have celebrated ten years of that partnership.

The partnership is one that will be fundamental to multi-agency integration within our Better Care Fund proposals. These will see us transfer care from institutional to community settings over coming months and years.

In 2006, and by public re-engagement in 2011, local partners consulted on the reconfiguration of services. This retains care in various existing locations across West Birmingham and Sandwell. It also moves care into new locations closer to resident's homes. But it does close two A&E departments, and create a single specialist acute centre at Grove Lane in Smethwick. This will increase transit times for some residents, but the balance of risk is that it permits greater concentration of expertise over a seven day period for patients.

We note and are pleased with CCG support for the new hospital and the Trust's recent reconfirmation of affordability within the new regulatory environment in their sector of the NHS.

I will ensure this letter of support is shared with other members of the Health and Wellbeing Board, to gain confirmation of their support too, at our next meeting on the 21st January 2014. We commend the scheme to you for urgent approval.
