In my role as Chair of the Charitable Funds Committee for Your Trust Charity - the registered charity of Sandwell and West Birmingham NHS Trust - I am very pleased to announce that last year was one of our most successful in recent memory.

Thanks to the hard work of key partners in our community, as well as our dedicated patients, families, carers and staff, Your Trust Charity surpassed the total income raised in 2017-18, and funded a number of very exciting projects in new and ongoing partnerships. This included piloting the alcohol service at the Trust, which has produced some fantastic results, detailed within this report.

For the second year running, Your Trust Charity was selected by the Mayor of Sandwell, Councillor Joy Edis as one of her chosen charities of the year, specifically supporting our Women's & Child Health appeal. Funds raised will be used to add enhancements to our maternity and child bereavement services.

This charity is very grateful to the grant aid secured from Sandwell Safer Partnership (SSP) towards our domestic violence support service in the Accident & Emergency (A&E) department, delivered by our partners Black Country Women's Aid. I am personally very pleased that this has enabled the Trust to sustain this vital service, following the pilot grant awarded by Your Trust Charity in 2015. Please read on for further details of this project's ongoing impact.

The year ahead is one of significant growth for Your Trust Charity as we continue to develop our donation pipeline for the £2.45m appeal to fund enhancements to the Midland Metropolitan Hospital. Donors will fund programmes associated with the arts, education and heritage as well as the latest equipment and additions to the environment.

In a time of economic and political uncertainty, it is so important for NHS charities to continue to add value and pilot new and innovative projects within their Trusts. This is a central aim of Your Trust Charity's strategy in the coming years ahead, and I will endeavour to make sure we can achieve this together."

What we have achieved

We are very pleased to report total charitable expenditure for the year of £1.335m. This reflects a planned deficit of £83,000, in keeping with Your Trust Charity's five year strategy, where one of our focuses is to reduce the overall balance of our restricted and designated funds spending our donations wisely in line with donor wishes.

Our charitable spend includes financial support for our two previous grant programme rounds in 2014/15 and 2016/17, as well as a new model we used in the last financial year to commission new funding requests.

Within **Infrastructure & Equipment**, commissions included the following one-off purchases of added-value equipment that enhances the care we can provide. These included:

- £76,017 for a high-end cataract training simulator at the Birmingham and Midland Eye Centre. This will improve our ability to provide excellent intraocular surgery training, including basic skills, surgical procedures and complications management.
- £41,750 for a Transabdominal Scan Trainer within the X-Ray and Imaging Department. This will improve access to ultrasound simulation training, rapidly increasing the student's rate of learning without disrupting clinical commitments.

Our Education & Development priority funds non-core or mandatory training requests from staff members that can demonstrate added value for patient care. For example, Your Trust Charity funded Julie Muircroft and Laura Browne, two of our heart failure specialist nurses, to attend the British Association for Nursing in Cardiovascular Care (BANCC) study day in Bristol. Julie said:

"The sessions were designed to help us focus on the whole family as a support function, so that we can better support patients living with heart failure". Our Innovation priority area has recently agreed to match fund support for an exciting new research collaboration with the University of Birmingham. This will support patients who are fighting cancer in their blood and/or lymph system - especially those from black and minority ethnic backgrounds.

This partnership will develop immunotherapy for leukaemia affecting the T cell. We are aiming to deliver later phases of this research through a patient trial at the new Midland Metropolitan Hospital.

This project would not have been possible without a charitable bequest from former patients at our organisation whose families were directly affected by leukaemia, as well as generous donations from local community organisations including the Michael Marsh Charitable Trust.

We are extremely grateful for their support, which has led to £256,000 being secured for this project to date.

Measuring impact: Our Grants Programme

At the heart of Your Trust Charity's work is our proactive approach to partnership working and community engagement. Our community resilience priority has therefore been the area that we have focused on to measure our impact.

We have continued to evaluate our charity funded projects in terms of:

- a) Evidence, feedback and performance monitoring about how the funds awarded was spent, the take-up by patients and whether there was potential for the project to be scaled up or mainstreamed
- b) Contribution to regional health and social care outcomes
- c) Support to the third sector, enabling awards of external grants, contracts and commissions

Evidencing of Project Achievements

Your Trust Charity has again applied the nationally recognised Housing Association Community Trust (HACT) Social Impact & Wellbeing Valuation methodology. This helps us determine where there was evidence of social impact achieved by our grants and commissioned projects.

Sapphire Service - awarded £109,080

Secured external funding of £368,000 from Sandwell MBC Better Care Fund

Initially the service was funded by Your Trust Charity as a 12 month pilot from April 2017 - March 2018. Delivered as a partnership by Agewell CIC and West Bromwich African Caribbean Care Centre and located at Sandwell Hospital, the Sapphire Service has continued to work with the Trust since the pilot.

Sapphire provides a 'bridging the gap' intervention and patient facing community based service, from hospital to home, addressing health, social care and wellbeing outcomes for vulnerable patients with dementia and at risk of isolation.

The project secured - with the development and bid writing support of the Your Trust Charity team - an additional £368,000 from the Better Care Fund commissioned by Sandwell CCG and Sandwell MBC to continue the project delivery until 2021.

The main beneficiaries are vulnerable elderly people benefitting from a 'wrap around' care planning service as part of their resilience to stay at home safely.

The scheme is now being recognised by the Trust, mainstream agencies and health and social care providers as a tried and tested model that is addressing a number of health related issues. The provision includes community dementia support, helping families with choice of accommodation, and support for carers so that patients can remain within a stable home environment. The scheme is contributing to reductions in delayed transfers of care and readmissions to hospital.

The project achieved the following results during the pilot:

- Patient Referrals Made = 890 (353 BAME)
- Carers Supported = 161
- Patient Re Admissions = Reduced by 49per cent
- Patient Length of Stay = Reduced by 67per cent
- Patients Diagnosed with Dementia Regularly Supported = 35

The beneficiary/patient was being provided with support services by the project, including input into care plans, signposting to welfare advice, anti-poverty & benefits take-up, and out of hours support for an averaged two to six hours per week for at least six weeks. The accumulated social value of the service calculated through the annual figure of the project grant (£109,080), is £1,771,251. This gives a social return on investment (SROI) of £16.24 per £1 spent.

Carers Support Project - awarded £47,740

The Carers Support Project, delivered by Sandwell CARES, was a pilot commissioned by Your Trust Charity from April 2017 - January 2019. It delivered a carers support service, providing information advice and guidance so that carers of the cared for or looked after individual were able to access help.

All beneficiaries had been diagnosed or suffered with a combination of illnesses or mental health conditions such as Alzheimers or Dementia. Others had severe cognitive illnesses and symptoms including those near end of life and requiring palliative care. Others supported had life threatening conditions.

The project engaged with 360 carers/families, 93 patients, and 141 staff/volunteers as shown here:

The carers identified were being provided with support services including signposting to bereavement & counselling services, anti-poverty and benefits takeup, campaigns and welfare advice.

Many had continued to access this support for an average two to six hours per week for a minimum of six weeks. The accumulated social value of the

service, calculated through the annual figure of the project grant (£23,750), is £230,860. This gives a social return on investment (SROI) of £9.72 per £1 spent.

Domestic Abuse Service - awarded £295,000

Secured external funding of £30,000 from Sandwell Safer Partnership (SSP)

Commencing in November 2015, Your Trust Charity provided 100 per cent funding to pilot an integrated response service to Domestic Violence and Abuse (DVA). In partnership with Black Country Women's Aid, the SWB safeguarding team, and our clinicians, this project operates within our emergency departments (ED) at Sandwell and City Hospitals.

During 2018-19, the charity's pilot funding for this service came to an end. However, the charity was able to secure a grant of just under £30,000 from Sandwell Safer Partnership (SSP) towards the Sandwell service. We are delighted that this has now enabled the Trust to take on and sustain this project across both sites.

Objectives of this project include:

 Improve identification of DVA victims presenting at ED - from November 2015 to July 2018, 491 patients were identified and referred to the service, with complex and multiple presenting issues as indicated below:

The Alcohol Service Team - awarded £235,329

Managed by clinical leads Dr Sally Bradberry and Arlene Copland (Lead Alcohol Nurse), the Alcohol Service Team based at City Hospital was a 12 month pilot project funded by Your Trust Charity (October 2017 - Octiober 2018). The team's work has been the coordination and delivery of a much needed bespoke clinical service with critical early intervention.

Project beneficiaries were patients and services users whose lives, health and social wellbeing had been severely impacted by alcohol, and therefore required to attend and routinely access the project's services at the front end of the hospital's entry point at City Hospital's Emergency Department (ED).

A dedicated project team was established to addressand tackle the core issues and challenges associated with those that were frequently intoxicated whilst arriving at ED. Some of these were returning as repeatattendees, others presented with symptoms because of ongoing illnesses, often aligned to a combination of medical and other health & wellbeing issues.

Patients at risk of severe self-harm and influences of other substances are provided with a 'safe haven' for sobering with a scaled-up interaction with the Alcohol Service team. As specialists, the team were able to develop their relationships with patients to identify where there was specific support required, resulting in much wider multi-agency support from clinical and non-clinical service providers. This includes social housing, reconnecting within the community and social groups, and, in due course, rehabilitation.

The project achieved the following results during its pilot:

- Seen and treated **over 260 people** with ages ranging from 17 to over 65, with 72 per cent of these admitted into hospital for treatment
- Just **under 26%** were a combination of homeless, rough sleeping, living in temporary

hostel accommodation and/or 'sofa surfing' with family or friends

- Saved over 80 bed days a month in the Trust
- Over 40 people now regularly access life skills training and take part in a positive activities programme that is focused around social care and health

This is boosting patients' self-confidence and selfesteem to effectively deal with the effects of alcohol abuse and in some cases their drug dependencies. This demonstrates how Your Trust Charity donations have been utilised to help improve the quality of life and the health and social wellbeing of our patients and services users. The project has now been sustained by the Trust.

Young People Sickle Cell and Thalassemia Project - awarded £2,475

Funded as a small grants pilot by Your Trust Charity, the project is coordinated and delivered by a dedicated group of four young adult volunteers Jenica, Sadeh, Abdul and Tayyib – all of whom are diagnosed with the disease since birth.

Although volunteer led, the project is supported by the hospital's Sickle Cell and Thalassemia (SCAT) clinical team of nursing staff, providing befriending support to other diagnosed young people and patients about coping with Sickle Cell and Thalassemia, pain management options, and information, advice and guidance.

Beneficiaries of the project are children and young adults with Sickle Cell and Thalassemia, helping them to transition from children to adult care, and to manage their condition

The project has engaged with 24 individuals to date, and has achieved the following:

- Provided a comfortable and secure meeting space on the wards within the hospital for conversations and treatment
- Offered a structured transitional pain management programme, delivered with external partners

- Provided education to patients, their carers and families on the reality of living and coping with the condition
- Supported and advised the higher learning and ambitions of patients and encouraged active participation and responsibility for their health outcomes

Through the use of personal case studies and life journeys about living with sickle cell, the project is exceeding what is provided through core NHS funding. By offering patient facing opportunities for individuals about improving their health outcomes by taking control, the project is inspiring the growing number of sickle cell patients not just in the region but across the UK. It is still ongoing and is seeking opportunities to develop further.

Fundraising and working within our community

We are one of the top three NHS charities by income in the West Midlands, and in the top 40 of charities operating in Sandwell (between £1m - £10m income). At the heart of this extremely eventful and successful year is the fantastic support from our partnerships, businesses and individuals. We are incredibly grateful to the hard work of our donors and supporters in ensuring that Your Trust Charity can continue to enhance the experience of all people using our services - including colleagues, patients and their families.

Particular thanks goes to that the Mayor of Sandwell for 2017-18, Councillor Ahmadul Haque, who successfully raised a grand total of £5,217 for Your Trust Charity, after supporting our cancer and research services during his mayoral year.

For the first time we have measured how many of our corporate and community supporters have offered to either volunteer their own time (worth £9 per hour using the Living Wage Foundation), or provide gifts in-kind for our wards and departments. Over the year, we have welcomed:

24 corporate/community partners providing £15,057 worth of time/in-kind gifts

This included Halfords in Oldbury who kindly donated two remote controlled sit in cars to our children's department. This allows children undergoing minor operations to be driven to the operating theatre where they will undergo their procedure. The car will be controlled by one of the play specialists and nurses. Three-year-old Gavy Saini, of West Bromwich, became the first patient to be driven to his operation. The youngster was undergoing a tooth extraction at the hospital and his mum admitted that he was feeling anxious. But as his car pulled up into the operating theatre, he beamed: "It's cool mummy." Mum-of-two Sundeep, 28, said: "This is a wonderful idea. Gavy wasn't really looking forward to coming into hospital, but when he saw the car, it definitely put him at ease."

We have also had a number of very successful fundraisers. At the start of this financial year, we cheered on PE teacher Elliot Browne as he completed the London Marathon and raised a target of £1,500 for Your Trust Charity. Elliot, who teaches at Bristnall Hall Academy, in Oldbury, said: "When you run, the only marathon you want to complete is London. When the opportunity to run for Your Trust Charity and raise some money for a great cause came up I couldn't pass on it. It's a lifetime ambition and it can now be ticked off my bucket list."



We would like to say a special thank you to Stan Green, one of our 10-year-old patients, who raised nearly £1,500 after taking on a gruelling triathlon. Stan waded through a freezing lake, completed a 1km run and a 2km bike ride – despite suffering from the illness Henoch-Schonlein purpura (HSP).

He decided to take part in the event to raise funds for Your Trust Charity as a way of saying thank you for the care he has received over the years.

He said: "When I was diagnosed with HSP, I never thought two years later I would be in a fit state to complete a triathlon. I even had to learn to ride a bike. But here I am today, having finished the challenge in 21 minutes. I'm really pleased to be able to do this and raise money for such a worthy cause."

The money will be used to buy more games consoles for older children who are treated at the hospital.

On 5 July we supported the NHS70 birthday celebrations by supporting the "Big 7Tea" parties at Sandwell Hospital and City Hospital, and raising funds for the charity to improve patient experience across the Trust.

Also in the summer we were extremely pleased to welcome Lilly and Fern - miniature Shetland ponies - as part of a pet therapy programme at Sandwell Hospital. The charity funded the Phoenix Children's Foundation to bring the tiny horses, allowing them to be petted and fed by stroke patients, as well as youngsters being treated by the paediatric team.

Arron Chohan, aged 11, from Tividale, had been at the hospital for a physiotherapy appointment and was left overwhelmed by his close encounter with Lilly and Fern.

He said: "They are really beautiful and their fur is soft. We heard there were ponies here, but I thought someone was joking. It's really cool and I've enjoyed meeting them today. It's a great idea."

In August, Your Trust Charity hosted their first garden party to celebrate the fantastic work our children's services deliver to our patients.

The party was open for all to enjoy and played host to a variety of fun and games from arts and crafts, to hook a duck with all the money raised from the special occasion going towards the children's department charitable trust fund. The party raised over £500 and put plenty of smiles on faces.

Children at the party had the opportunity to meet Dippy the Clown as a special guest. Jez Jones, Matron - Acute Paediatrics, was delighted with how the party went: "Thank you to everyone who worked so hard to make the party such a success."



The following month, Jasmeet Dhaliwal raised an impressive £540 for the charity by jumping 10,000ft out of a plane despite her fear of heights.

She said: "Initially I was apprehensive as I have a big fear of heights. The parachute doesn't open until you reach 5,000ft and you're travelling at speeds of up to 120mph.

"However I overcame this fear as I wanted to raise money for Your Trust Charity. I work at the hospital as a Senior Management Accountant, and had heard about the amazing work the charity does for our patients."



In October, we opened the new Volunteer and Charity Hub at City Hospital. The Hub acts as a base for wayfinding volunteers, who aim to guide patients and visitors to their intended destination. This is part of the 'Meet and Greet' scheme that the charity funds. Volunteers also play an important role in raising the profile for Your Trust Charity and our work.

Your Trust Charity was delighted to pay £7,704 for the neonatal department at City Hospital to buy a brand new next generation incubator which gives premature and poorly babies a helping hand as they grow and develop. The Dräger Babyleo TN500 is the latest hybrid incubator that has been designed to continually stabilise the baby's temperature, provide noise and light monitoring, positive sound stimulation, support family-centered care, and excellent infection prevention.

One of the first babies to use the new incubator was Harvey Singh who was born at 32 weeks and had spent the last four days in the incubator.

Beaming parents Amarjit Kaur and Parvinder Lidder were keen to share their experience. They said: "The staff in Neonates have been amazing, it's obviously been a nerve-racking few weeks but the care and support we've had has been second to none."



Patients on Lyndon 1 can now tap away with joy on brand new tablets thanks to a generous donation from the telecoms giant BT. Tom Hannibal, Team Manager at BT, Providence House, said: "We're always looking for worthy causes to help and we have a fundraiser each month to support the local community. Our staff at BT had a great time raising money by selling samosas and cakes and with the money raised we were able to buy not one but four tablets for the hospital."

Joanne Wright, Ward Manager on Lyndon 1 said: "Coming into hospital is often a very stressful experience and whilst we do everything we can to keep our patients calm, we're always keen to help distract and entertain our young patients. "These tablets will give us the ability to provide a welcome distraction to patients on our ward, they can sit, relax, watch a video or simply play a game from the comfort of their own bed whilst they rest and recuperate."



This year we were thrilled that one of our fundraisers, Sally Gutteridge was crowned 'Community Most Valuable Player' by Aston Villa Football Club in recognition of her contribution to the local community and her ability to inspire others.

Mum-of-two Sally was nominated after she raised £2,526 for the charity during 2017 – despite suffering a stroke and being told she had a second brain tumour.

Sally decided to fundraise for Your Trust Charity to give something back to those who had been caring for her. Her latest fundraising project - Sally's Sunshine Packs - are goodie bags for chemotherapy and end-of-life patients who are in our care. The packs will contain items such as puzzle books, a journal, sweets, wet wipes, shampoo and tissues.

Sally said of these packs: "They will mean so much to patients. I remember seeing others undergoing treatment who were there by themselves. I just thought it would have been so nice for them to have something that they could take home, that was useful.



We are also very grateful to A&A Walters Funeral Directors who raised £608 for the paediatric department after learning about the excellent care that our team gave Maddy Box-Poole, who died last year after losing her battle with batten disease. Director, Rachel Hodges, explained: "We were privileged to organise the funeral for Maddy, who was only 10 years old when she passed away. So we thought we would like to do something for the children's department and contacted Your Trust Charity. We are glad that the money will be used to buy baths that will enhance the care of babies."



Thank you to SWB NHS Trust Audiologist, Chan Gill for his fantastic fundraising efforts. Fifteen months ago, Chan and his wife Suki experienced life on the other side, after their son Chayten was born premature and spent the first four months of his life in the neonatal unit at City Hospital. Since Chayten was born, Chan did not cut his hair or have a shave, but decided to have his locks chopped off as a way of saying thanks to the team for the incredible care the family received.

Chan said: "This was the most stressful and worrying time of our lives, and it was our faith in God that kept us going. The care that Chayten and we as his parents received from the team on neonatal was outstanding. They couldn't do enough for us and our family at a period when we needed them the most."

Your Trust Charity filmed the moment Chan had his hair cut at The Gentleman barbers, and were

so relieved he was happy with his new look and the fantastic support he received from his friends and family, raising a grand total of £2,316 for the neonatal unit.



During Christmas, we once again received many very kind donations from our community for our patients who were in hospital. We cannot thank you all enough for your kindness and generosity. We had groups decorate our children's departments, elderly care wards and also had a local school spend the morning with us singing across the wards.

We welcomed players from West Bromwich Albion at Christmas to meet our young patients. The stars, Ben Foster, Jonny Evans, Gareth Barry, James Mclean, and Grzegorz Krychowiak, came armed with presents for the children, but also a handful of memorabilia including a football, calendars and t-shirts - donated to Your Trust Charity.

Across our community we had some fantastic people give their time to knit gifts for our patients, including twiddle muffs, breastfeeding boobs, baby bonnets, and blankets for young and old – as well as a crochet octopus for our premature babies.

Local charitable groups have also shown community generosity to Your Trust Charity. The Wahegru Foundation led a book and toy drive across the country, to make sure no child went without a gift at Christmas. The Sikh Toy Appeal based in Wolverhampton also supported us with gifts to give our patients who were receiving care. Free Radio Cash for Kids also provided 160 toys for our patients.

With all of the donations received we were able to give every child in hospital over Christmas a gift.

We also kitted out the playrooms on four of our wards so all children coming into our hospital are now able to use play as part of their rehabilitation.

The Aashiana charity also raised £500 to help Your Trust Charity deliver a 'winter wellness pack' project. This initiative aimed to give extra support to our elderly and vulnerable patients. The Aashiana charity, which is a group of friends and families, raised money to help Your Trust Charity buy essential items, such as gloves, scarves, tea and coffee, to give to patients when they are discharged. Mr Puri, the Chairman of the charity, said: "We are delighted to make this donation to the Trust and we hope that our little gift can make a difference to someone during this winter.

Also during the festive season, X Factor judge Simon Cowell made a special appearance at the launch of O Holy Night, performed by The Heartbeats Choir at an Oldbury school - or so it seemed. In fact it was Dudley-based lookalike Andy Monk who attended the official first performance of the single, which was recorded in conjunction with Bristnall Hall Academy, and Your Trust Charity. The song, released on 26 November, went headto-head with the winner of TV show X Factor and other chart-topping artists.

It featured the vocal talents of students, teachers, school governors, Police Community Safety Officers, healthcare workers, and local celebrity Kash "the Flash" Gill, four-times world Kickboxing champion. There was also support from Baggie Bird, the West Bromwich Albion mascot.

Cash raised from sales will go towards enhancing the experience of patients, visitors and staff to Sandwell, City and Rowley Regis Hospitals.

Vince Green, Principal at the school, said: "This is an amazing initiative from Your Trust Charity raising funds for such a very worthy cause. Students and staff at Bristnall Hall Academy were honoured to be invited to host the recording and sing with staff from the Trust who kindly committed their time and talent to the single. It will be great to see this charity single being well supported by people from our community and beyond."

The Midland Metropolitan Fundraising Campaign

We are extremely pleased the Midland Metropolitan construction situation was resolved last year. The government will publically finance the completion of the hospital, which will open in 2022. This gives Your Trust Charity - and our community - a unique opportunity to celebrate triumph overcoming adversity, and to galvanise together in marking this momentous achievement.

Your Trust Charity is committed to running a fundraising campaign generating a minimum £2m. Our campaign will enhance the benefits of the new hospital site for people within the local community, improving the experience of patients and their carers, visitors and staff. This campaign has always been about funding these enhancements, which are entirely separate from the publically financed costs the government has agreed to pay for – and are outside of core NHS funding. Our fundraising campaign will add value by:

1. Creating new community spaces - such as galleries, exhibition spaces and gardens

- 2. A welcoming, healing environment furnishings and facilities that exceed NHS specifications
- 3. Enhanced research and development better understanding conditions of all our patients

To date, just over £320,000 in total has been raised for the campaign, as we plan to publically launch our fundraising campaign in late 2019. We are very grateful to our donors and supporters, including the Wellcome Trust who has made a £15,000 grant to our campaign. This will allow us to commence work on our arts and heritage strategy for the new hospital.

We would like to extend our sincere thanks to the Chair and members of our Leadership Committee. They are working with us behind the scenes to develop a fundraising campaign that will ensure the Midland Metropolitan becomes more than a hospital.

Our future plans

We have now completed the second year of our five year fundraising strategy to 2021/22, which aims to position Your Trust Charity **as a key service deliverer and facilitator of partnerships within the region**.

Our objectives are as follows:

- Increase awareness of the Charity's brand with a continued integrated marketing and communications campaign i.e. website, annual report, and 'storytelling'.
- 2. To further develop partnership funding bids for external grant makers.
- 3. Deliver an effective grant making strategy, with effective impact and evaluation.
- 4. Engaging staff in becoming active in a programme of annual fundraising events.
- 5. A revised and updated membership scheme, which will increase number of active members/ volunteers.
- 6. Develop transactional and strategic CSR relationships with Sandwell and Birmingham employers.
- 7. To have created strong internal relationships with finance and fund managers.
- 8. To adopt robust processes and procedures with Finance and Cash Office that meet audit recommendations, including the maximisation of tax-effective giving i.e. Gift Aid.
- 9. To have raised £2m (net) for the Midland Met Appeal by 1st January 2022 in pledges.

We continue to diversify our income streams and look at alternative and new sources of income, focusing in particular on:

1. Individuals - regular giving (including payroll giving) and legacies

Shortly within the next year, we will launch our micro-grants scheme, where we will encourage all colleagues to use payroll giving to become a member of this scheme. This will allow them to submit small ideas that will make a big difference, and help us to select which ideas to fund.

Recognising how important legacy income is to Your Trust Charity, in the last year we launched our 'Planning for Your Peace of Mind' guide with our palliative care service. This guide acts as an introduction to Your Trust Charity and the services of our charity partners, Dunham McCarthy and Dignity plc. In the next year we plan to roll this guide out to other services within our Trust, where being able to plan for later life would help to enhance the care of our patients.

2. Corporate - 'transactional' donations, sponsorship and in-kind, and 'strategic' partnerships

Following our first measurement of 24 of our corporate and community supporters providing £15,057 of their own time or gifts in-kind for our wards and departments, we will look to build on these great relationships and move towards more strategic partnerships.

3. Trusts, grants and foundations

We have yielded very positive results from accessing external grants - in particular partnership bids - and we are developing a number of exciting major grant bids in the next year.

4. Major gifts (through the Midland Metropolitan Campaign)

Monitoring our Fundraising Performance

Your Trust Charity continues to grow income yearon-year. Our objectives and performance continue to be monitored and governed by the Charitable Funds Committee, a Sub-Committee of the Trust Board, chaired by a Non-Executive Director. In summary, the Corporate Trustees of Your Trust Charity have continued confidence in the five year strategy to increase total income year-on-year up to 2021/22, supported by the charity brand which will continue to act as a focal point to re-engage with our supporters and donors.

CHARITY TRUSTEES:

The Charity has a Corporate Trustee, the Sandwell and West Birmingham Hospitals NHS Trust (established by Statutory Instrument in March 2002 under the NHS and Community Care Act 1990). The NHS Trust Board comprises the Chairman, seven Non-Executive members and five Executive members. Non-Executive members are appointed by NHS Trust Development Agency (now NHS Improvement) and the Executive members are all Directors of the NHS Trust and comprise the Chief Executive, the Director of Finance and Performance, Chief Nurse, Medical Director and the Chief Operating Officer.

The NHS Trust Board has devolved responsibility for the ongoing management of funds to a Charitable Funds Sub-Committee of the Board which administers the funds on behalf of the Corporate Trustee. The Committee meets four times a year. Representatives of the Charitable Fund Investment advisors are required to attend the Committee on a twice yearly basis to present appropriate investment reports.

OBJECTIVES AND STRATEGY

All Charities must have charitable purposes or aims that are for the 'public benefit'. This is known as the 'public benefit requirement'. 'Public benefit' is the legal requirement that every organisation set up for one or more charitable aims must be able to demonstrate that its aims are for the public benefit if it is to be recognised, and registered, as a charity in England and Wales. There are two key principles, both of which must be met in order to show that an organisation's aims are for the public benefit. Firstly there must be an identifiable benefit or benefits and secondly the benefits must be to the public or section of the public. The Corporate Trustee confirms that it has had regard to the Charity Commission public benefit guidance where relevant. The Charity has a main Umbrella Charity, formally known as **"Sandwell and West Birmingham Hospitals NHS Trust Charities"**. The objects of this fund are registered as being:

"To apply the income for any charitable purpose or purposes relating to the National Health Service wholly or mainly for the service provided by Sandwell and West Birmingham Hospitals NHS Trust."

This main charity fund is considered to have NHS wide objectives and as such the Corporate Trustee considers this to be for the public benefit and as such complies with the Charity Commissions guidance on public benefit.

STRUCTURE, GOVERNANCE AND MANAGEMENT

The Charity's main fund was established using the model declaration of trust and all the funds held on trust as at the date of registration were either included as part of this unrestricted fund or registered as part of separate restricted funds under the main umbrella charity. As of 10th May 2017, the previous linked charity structure was dissolved and merged into the main umbrella NHS charity, in line with the charity's appeals.

During 2017/18, continued consolidation of designated funds took place, with reduction to c. 200 funds in total. There are fund manager(s) appointed whose responsibility it is to ensure that the funds are spent accordingly. An updated Charitable Funds Policy was agreed by the Charitable Funds Committee in 2017/18, to outline best practice in terms of appropriate charitable spend. Under a scheme of delegated authority approved by the Corporate Trustee these fund managers have delegated authority for expenditure, excluding salaries, to spend up to £5,000 per request in conjunction with a nominated representative of the Director of Finance. Requests less than or equal to £20,000 require the authority of the Fund Manager and the Director of Finance; requests less than or equal to £50,000 require the authority of the Fund Manager, Director of Finance and the Executive Director responsible for the requesting

department. Any request in excess of £50,000 requires the approval of the Charitable Funds Committee. In the case of any salary expenditure (including on costs) as part of a linked research programme then this will require the approval of the Fund Manager, Director of Finance, and Director of Research and Development.

Restricted Funds

Individual fund managers are required to submit annual plans to the Corporate Trustee detailing how and on what the restricted funds are to be spent. The Corporate Trustee regularly monitors this spend against the available fund balance and takes appropriate action to ensure that funds are spent in a timely manner and in accordance with the donor's wishes.

Designated Funds

Where general donations are received on behalf of individual wards or departments of our organisation, the Corporate Trustee has agreed to transfer the donations received to a fund designated for that particular ward or department. By their very nature these funds are generally held for the purposes of satisfying needs on a day to day basis rather than for long term projects. Internal controls prevent the possibility of these funds spending in excess of the outstanding balance.

Individual fund managers for these ward and departmental designated funds are required to submit annual spending plans to the Corporate Trustee setting out how they intend to spend the balance on their fund on an annual basis.

Other designated funds may be created from time to time by the Corporate Trustee in order to fund specific charitable activities.

It should be noted that the designation of funds does not commit the funds legally. Such designation may be cancelled by the Corporate Trustee if it is later decided that the Charity should not proceed or continue with the use or purpose for which the funds were originally designated.

Legal Duties

The Corporate Trustee fulfils its legal duty by ensuring that the funds are spent in accordance with the objectives of each fund and, by designating certain monies within the existing charities, the Corporate Trustee is able to respect the wishes of our generous donors to benefit patient care and advance the good health and welfare of patients, carers and staff.

Non-Executive members of the Trust Board are appointed by the NHS Trust Development Agency (now NHS Improvement) and Executive members of the Board are subject to recruitment by the NHS Trust Board. Members of the Trust Board and the Charitable Funds Committee are not individual trustees under Charity Law but act as agents on behalf of the Corporate Trustee.

Acting for the Corporate Trustee, the Charitable Funds Committee is responsible for the overall management of the charitable funds. As defined in the updated Charitable Funds Policy, the duties of the Committee are to:

- Act in the best interests of the Charity
- Manage the Charity's resources responsibly, which includes protecting and safeguarding its reputation
- Act with reasonable care and skill

The Committee is authorised by the Trust Board to:

- To investigate any activity within its Terms of Reference. It is authorized to seek any information it requires from any employee and all employees are directed to co-operate with any request made by the Committee.
- To instruct professional advisors and request the attendance of individuals and authorities from outside of the Trust with relevant experience and expertise if it considers this necessary or expedient to carrying out its functions.
- To obtain such internal information as is necessary and expedient to the fulfillment of its functions.
- Trustees are legally responsible for the Charity's fundraising. Operating effective control over the Charity's fundraising is a vital part of their compliance with legal duties as outlined in the commission guidance on the Trustee duties

set out in "the essential Trustee: what you need to know, what you need to do "(CC3).

The Trustees have the right to:

- Prevent the withdrawal of funds, which do not meet the conditions set out in these guidelines.
- Authorise expenditure from a fund if the Trustees believe this to be an appropriate use of resources.
- Cease to delegate their authority to a Fund Manager if they believe that the regulations in this document are not fulfilled. In this case they may appoint an alternative manager or take control of the fund themselves.
- Amend these Guidelines as and when necessary. Amendments will be communicated to all Fund Managers.
- Authorise investigation of a breach of this policy that may result in the matter being treated as a disciplinary offence under the Trust's disciplinary procedure.

The accounting records and the day-to-day administration of charitable funds are dealt with by the NHS Trust Finance Department which is located in Trinity House on the Sandwell General Hospital Site, Lyndon, West Bromwich, B71 4HJ. The NHS Trust levies a charge for providing this service which is reviewed on an annual basis.

RISK ASSESSMENT

A summary of the major risks to which the Charity is exposed have been identified and placed on the Trust's Risk Register. A summary of responsibilities for managing those risks and the control and security systems in place to alleviate these risks are also summarised below:

Financial Risk

- Investments and/or major assets are not properly safeguarded.
- Expenditure is inappropriately high/low, not correctly authorised, or not spent for purposes intended.
- Income is not encouraged, not appropriated to specific funds, or not recognised.
- Accounting transactions are inadequately recorded.

Operational Risk

- The Charity is not operating within its objectives or cannot sustain income streams to meet demand for its objectives
- Risk of inadequate insurance cover, the public profile of the charity, management & admin expenditure, fraud, and quality of services
- Risk of charity sector experience and level of involvement in management of the charity

Compliance Risk

 Risk in relation to VAT/Corporate Tax; legislation i.e. GDPR/Data Protection/Human Rights/Health & Safety/Employment law; and statutory accounts i.e. SORP compliance and accounting standards

Reputational Risk

- Risk of negative press and social media stories
- Risk that campaigns are not funding enhanced services and do not represent value for money

The Charitable Funds Committee, Chair of Corporate Trustee, Director of Finance, Director of Organisational Development, Director of Communications and Head of Trust Charity will regularly monitor, review and review on procedures in place and performance in relation to the above, obtaining professional advice where applicable.

The Corporate Trustee is content that the controls described have operated effectively during the year and therefore that the risks outlined have been mitigated.

The most significant ongoing risk to the Charity is the potential losses arising from a fall in the value of the investments held and the level of reserves available to offset the impact of any such losses. These have been carefully considered and there are procedures in place to review the investment policy and to ensure that both spending and financial commitments remain in line with income streams.

PARTNERSHIP WORKING AND NETWORKS

The Charity continues to be a member of the Association of NHS Charities. This organisation ensures that the Charity is kept informed and fully updated on all current and developing issues in relation to charitable funds. Concerns are highlighted and the knowledge shared with similar organisations.

SWBH NHS Trust Charities contracted Morgen Thomas in 18/19 to provide specialist strategic advisory services relating to the Midland Met campaign. This focused on strategic development. Morgen Thomas were not contracted in a professional fundraiser or commercial participator capacity, and both Morgen Thomas and Sandwell and West Birmingham Hospitals NHS Trust NHS Trust Charities abide by the Code of Conduct of the Institute of Fundraising.

Sandwell and West Birmingham Hospitals NHS Trust is the main beneficiary of the Charity and is a related party by virtue of being the Corporate Trustee of the Charity. By working in partnership with the Trust, the charitable funds are used to the best effect for public benefit. When deciding upon the most beneficial way to use charitable funds, the Corporate Trustee has due regard to the main activities, objectives, strategies and plans of the NHS Trust.

Income 2018-19

Improvements in the stock market have had some effect on the level of fund balances and a degree of cautious optimism remains for the medium to long term. The Charity continues to be heavily dependent upon the generosity of the general public, grants from commercial and non-commercial organisations and income from investments held to fulfil its objectives. The considerations given by the public usually represent the excellent standard of care received from the staff of the Hospital whilst they, or a relative or a friend, were being treated in hospital, or to assist the Trust in providing additional facilities and comforts for patients. Grants from commercial organisations are usually given in support of essential ongoing charitable medical research in various clinical areas. The income received from investments (i.e. company dividends and bank interest) is apportioned annually. The resulting income is to be subsequently applied in accordance with the objectives of the fund.

The Charity committed £1.334m during the year to enhance the experience of all people using services, including staff, patients, and their families. This reflects a planned deficit of £83,000, in keeping with Your Trust Charity's five year strategy, where a major focus is to reduce the overall balance of restricted and designated funds.

The main areas of expenditure were in line with the four priority areas, namely:

- Infrastructure & equipment
- Education & development
- Research & innovation
- Community resilience

Investments

The Corporate Trustee is empowered under the declaration of trust to invest funds in stocks and shares. Following a re-tendering exercise in February 2008 the Corporate Trustees re-appointed Barclays Wealth to provide continuing advice in respect of the management of investments. The Charities holdings are held in "nominee" company with Barclays Wealth.

The Charity has an ethical approach to investment and moderate risk appetite in the management of its funds.

Surplus cash of £2.019m was held in Treasury Bond and short term deposit accounts, to ensure the charity has sufficient liquid cash resources to meet the liabilities of the charity.



The funds of the Charity were invested as follows at 31 March 2019:

Managed investment - Asset allocation

Historically a weak £ has been positive for the FTSE 100 as can be seen after the result of the Brexit vote on 24th June 2016 with the FTSE 100 rallying strongly in the second half of the year. This is because the constituents of the index have a significant proportion (c. 70 per cent) of the earnings being generated in USD.

A weak f in the event of a hard Brexit is unlikely to yield the same result in uplift in the FTSE 100 as it would in all likelihood create a "risk off" environment and hence the benefit of having a well-diversified portfolio (as detailed above) will be key with parts of the portfolio performing well whilst others may be under short-term stress.

The £ did rally (against EUR and USD) where chances of a "no deal" Brexit diminished and a softening in rhetoric from some EU members regarding the back stop on the Irish border.

STATEMENT OF INVESTMENT POLICY

The Corporate Trustee has approved the following statement of investment policy:

1. The Charity utilises professional investment advisers to support the active implementation of its investment policy and their performance is reviewed annually.

- 2. The Charity objectives for investment are:
 - 2.1 Maintaining and growing the capital value of its investments portfolio over time
 - 2.2 Generating income from its portfolio of investments
 - 2.3 A target income stream of £175,000 per annum, to be reviewed by the Corporate Trustee on at least an annual basis.
- 3. To achieve its objectives, in paragraph two above, the Charity shall, having taken into account the view of its brokers/advisers, maintain an appropriate balance in its investments portfolio between fixed interest investments and equities.

Portfolio target asset allocation ranges shall be set by the Corporate Trustee and reviewed, having taken into account the views of the investment advisors, on at least a biannual basis.

4. The Charity's investment policy precludes the investment in companies with a significant interest in tobacco, alcohol or armaments.

The Corporate Trustee periodically reviews the way in which the portfolio is managed by the investment brokers with a view to exploring short and long term positioning within portfolios, as well as alternative options.

RESERVES POLICY

The charitable funds committee has established a reserves policy as part of their plans to provide long term support to the four priority areas of the charity:

- Community Resilience
- Infrastructure and equipment
- Research
- Education and Development

The charitable funds committee calculate the reserves as that part of the charity's unrestricted funds that is freely available after taking account of:

- 20 per cent buffer for contingencies for example
 to cover investment fluctuations due to market forces (i.e. Brexit)
- 40 per cent minimum spend of designated funds (core activities)
- 40 per cent forward planning budget for commissions(core activities)

Based on the assessment of the charity's risk, income and expenditure as completed in November 2018, the proposed target range for reserves is between £1m to £1.5m.

The reserves held are currently below our target range due in large part to the ongoing expenditure of grants and commissions, as well as funding the Your Trust Charity team. The charitable funds committee review the balances held in designated funds regularly through a 'dormant funds pathway' to determine whether inactive funds are likely to be committed in the near future and the extent to which there is a continuing need identified for any particular designated fund(s).

ACCOUNTING AND REPORTING RESPONSIBILITIES

The Charities Act 2011 requires the Corporate Trustee to prepare accounts for each financial year which give a true and fair view of the Charity's financial activities during the year and of its financial position at the end of the year. In preparing these accounts the Corporate Trustee is required to:

- apply accounting policies on a consistent basis
- make judgements and estimates which are reasonable and prudent
- follow applicable accounting standards and the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102), disclosing and explaining any material departures in the accounts
- prepare the accounts on the going concern basis unless it is inappropriate to assume that the Charity will continue in operation.

The Corporate Trustee is responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the Charity and to enable them to ensure that the accounts comply with charity law. The Corporate Trustee is also responsible for establishing and monitoring a system of internal control and establishing arrangements for the prevention and detection of fraud and corruption.

The Corporate Trustee confirms that they have met the responsibilities set out above and complied with the requirement for preparing the accounts on a going concern basis.

Notes on the accounts

1. Accounting Policies

(a) Basis of preparation

The Charity is a public benefit entity. The financial statements have been prepared under the historic cost convention, with the exception of investments which are included at fair value.

The accounts (financial statements) have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014 and the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) and the Charities Act 2011 and UK Generally Accepted Practice as it applies from 1 January 2015.

The trustees consider that there are no material uncertainties about the SWBH Charities' ability to continue as a going concern. There are no material uncertainties affecting the current year's accounts.

In future years, the key risks to the SWBH Charities are a fall in income from donations or investment income but the trustees have arrangements in place to mitigate those risks (see the risk management and reserves sections of the annual report for more information).

(b) Funds structure

Where there is a legal restriction on the purpose to which a fund may be put, the fund is classified as restricted.

Restricted funds are those where the donor has provided for the donation to be spent in furtherance of a specified charitable purpose. SWBH Charities' restricted funds tend to result from appeals for specified purposes.

Those funds which are not restricted income funds, are classed as unrestricted income funds which are sub analysed between designated (earmarked) funds where the trustees have set aside amounts to be used for specific purposes or which reflect the non-binding wishes of donors and unrestricted funds which are at the trustees' discretion, including the general fund which represents the charity's reserves. The major funds held in each of these categories are disclosed in note 26.1

(c) Incoming resources

All incoming resources are recognised once the charity has entitlement to the resources, it is probable (more likely than not) that the resources will be received and the monetary value of incoming resources can be measured with sufficient reliability.

Where there are terms or conditions attached to incoming resources, particularly grants, then these terms or conditions must be met before the income is recognised as the entitlement condition will not be satisfied until that point. Where terms or conditions have not been met or uncertainty exists as to whether they can be met then the relevant income is not recognised in the year but deferred and shown on the balance sheet as deferred income.

(d) Incoming resources from legacies

Legacies are accounted for as incoming resources either upon receipt or where the receipt of the legacy is probable.

Receipt is probable when:

Confirmation has been received from the representatives of the estate(s) that probate has been granted

The executors have established that there are sufficient assets in the estate to pay the legacy and

• All conditions attached to the legacy have been fulfilled or are within the charity's control.

If there is uncertainty as to the amount of the legacy and it cannot be reliably estimated then the legacy is shown as a contingent asset until all of the conditions for income recognition are met.

(k) Debtors
